Une **modification majeure (maj.)** est définie comme une correction pouvant avoir un impact sur le résultat de l'élève si elle n'est pas apportée.

Exemples : Ajout d'un élément de réponse dans le corrigé, modification d'une tâche, ajout d'une annexe utile pour la tâche, modification de la pondération, etc.

Une **modification mineure (min.)** est une correction apportée à l'épreuve qui n'a pas d'incidence sur le résultat de l'élève.

Exemples : Ajustement de la mise en page, rectification orthographique ou typographique, etc.

MAJOR VS. MINOR MODIFICATIONS

A **major modification (maj.)** is defined as a correction that has an impact on students' results if it is not made. For example: addition of an item to the correction key, modification of a task, addition of an appendix required for the task, a change to the marking scheme, etc.

A **minor modification (min.)** is a correction that has no direct impact on students' results. For example: formatting of pages, revision to spelling or typo errors, etc.
