

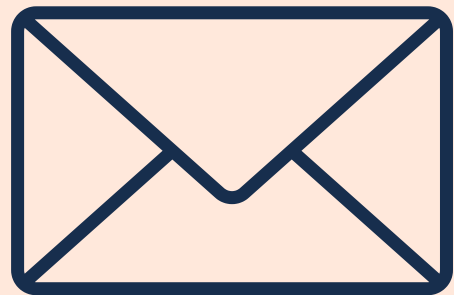

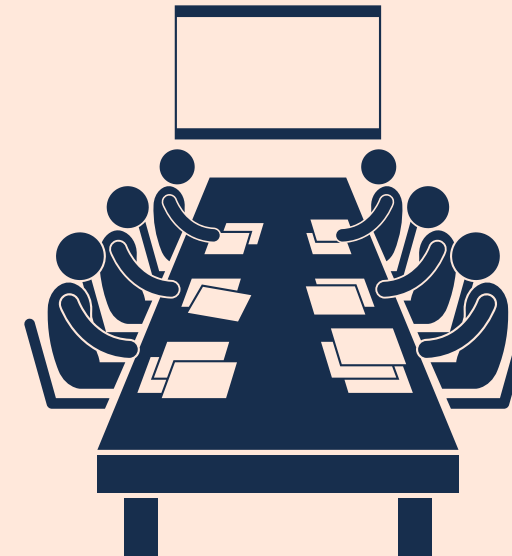

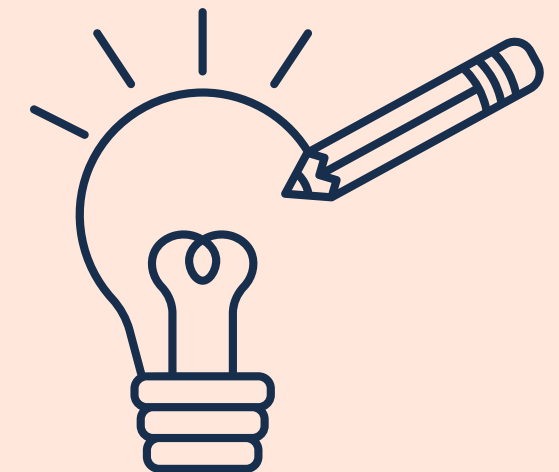

- Information Bulletin inviting educational institutions to collaborate on validating evaluation specifications (30 marks) to create the BIM Reference Framework and developing examinations.

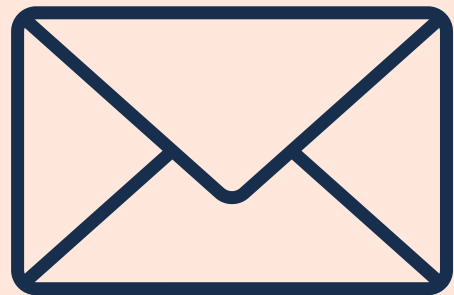

 - publication of final versions of examinations in the BIManger (GeXamine) bank

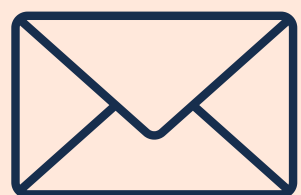
